- Glavni koordinator projekta zajedno sa svojim najbližim suradnicima bit će odgovoran za odabir sudionika u projektu, njihovu pripremu i njihovu podršku za svo vrijeme trajanja projekta. Temeljni principi kojima će se ti ključni ljudi rukovoditi su transparentnost, pravednost i jednakost za sve. Jednako tako, ti će ljudi biti dostupni svim sudionicima projekta iz bilo kojeg razloga i u bilo koje vrijeme aktivnosti.
- Stručni tim vrtića i ravnateljica nadležni su za kontinuirano stručno usavršavanje odgojitelja i odabir članova Projektnog tima, kojeg vodi ravnateljica. Za evaluaciju i prepoznavanje ishoda učenja bit će odgovoran poseban odbor u koji će biti imenovani ključni ljudi odgovorni za projekt.
- Ravnateljica, psihologinja i pedagoginja odgovorne su za provedbu svih segmenata projektnih zadaća. Po povratku s mobilnosti daje se opširno izvješće u usmenom i pisanom obliku koje se evaluira na sastanku stručnog tima. Za svaku mobilnost psihologinja sastavlja anketu koja uključuje segmente osobnog zadovoljstva, stručnog postignuća, stečenih jezičnih i socijalnih kompetencija te primjenjivost sadržaja. Pedagoginja evaluira rezultate ciljeva mobilnosti i rezultat ankete nakon mobilnosti.

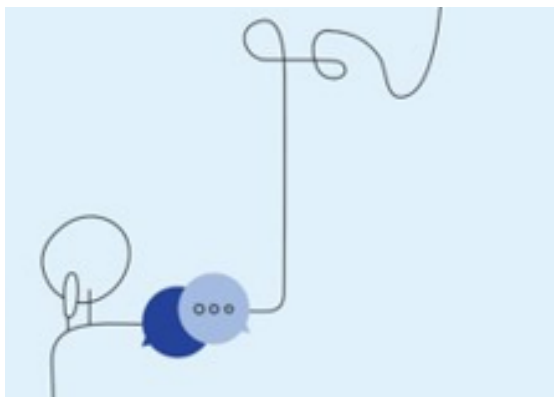

Evaluacija: što - zašto - kako

- procjenjivati, ocjenjivati, mjeriti i pratiti sve aktivnosti, ciljeve i rezultate projekta
- Svrha: poboljšanje kvalitete sudjelovanja svih dionika na projektu, procjenu svake faze projekta, uključujući dizajn, implementaciju i rezultate
- Koga uključiti?
- Koliko često?
- Ne zaboraviti polazne vrijednosti



- što više metoda i područja mjerenja, evaluacija je uspješnija
- područja mjerenja - povezana s ciljevima
- u anketama i upitnicima **ne postavljati načelna pitanja** (jeste li zadovoljni?) i ne ispitujte samo zadovoljstvo
- podatke prikupljene u sklopu praćenja i vrednovanja provedenih aktivnosti iskoristite za unaprjeđenje nadolazećih aktivnosti
- pravovremenost - ključna! (evaluaciju provoditi u vrijeme kad se može dobiti smisljena povratna informacija koju možete iskoristiti)
